Release Notes Viedoc 4.84

New and updated functionality



List of functionalities that have been added and updated in this release.

Viedoc Designer

- A study designer can now compare two different design versions within a study. The
 compared output is presented to the user in a new browser tab and shows additions,
 removals, and modifications from a source design to a target design. The changes are
 listed in the same order as in the design ODM file and include references to the relevant
 sections in the ODM file. For information about limitations when comparing with designs
 created prior to this release, and for additional information, please see the Viedoc
 Designer User Guide.
- Viedoc Designer is now supported in Polish and Portuguese.

Viedoc TMF - New UI

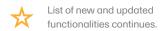
- We are introducing a new user interface (UI) for Viedoc TMF that offers simplified and structured navigation, improved visual clarity, and enhanced user experience.
- When launching Viedoc TMF, the user is presented an option to launch the new interface or continue using the old interface. It is possible for users to switch between the old and new UI at any time.
- The new interface introduces a new left-hand menu for easier navigation across the TMF. Here users can easily move between the different areas and pages (Trial Master File, TMF Admin, TMF Archive), access new Viedoc Learning lessons, or switch back to the old UI.
- In the new interface, the term "Documents" is replaced by "Records" to align the industry terminology trends.

Viedoc Admin/Clinic

- The user administration log now contains a new tab, "User Invitation Log", with information about pending and rejected invitations. The new tab includes:
 - Email address of invited user
 - Details about the initial invitation
 - Number of times an invite has been resent
 - Invitation status (pending or rejected)
 - Invitation rejection date/time
- When a user accepts an invite, there will no longer be a record in the "User Invitation Log", but instead the details will be included in the "User Access Log".

Viedoc Clinic

- On the Viedoc Me activation screen, when sending test emails and text messages, there is now a delay of 15 seconds before the link to trigger new test emails and text messages appears. This is to prevent users from triggering multiple test emails and text messages in quick succession.
- When sending emails from the metrics page, there is now a delay of 15 seconds before the link to send a new email reappears. This has been introduced to prevent users from triggering multiple emails in quick succession.

Viedoc Admin

- When resending invitation emails to users, there is now a delay of 15 seconds before
 the resend invitation link is shown again. This is to prevent users from triggering
 multiple emails in quick succession. To harmonize the UI, the resend link has been
 moved to the rightmost side of the row.
- Viedoc Admin is now supported in Polish and Portuguese.

Bug fixes



List of bug fixes that have been updated in this release.

This section lists the bugs that were solved in this release. For each bug, it describes the following:

- Affected area(s): describes briefly which area(s) of Viedoc the bug is related to, so that it is easy to identify if any of your active studies are affected.
- Bug description: explains the issue and/or how it was solved. In case there are consequences for existing data, this is clearly mentioned in a "Note!".

The following corrections have been implemented in the Viedoc 4.84 release:

- Affected area(s): Viedoc Admin
 Bug description: When adding a new site, the format of the site manager email
 address was not validated to confirm it was a valid email address. This has been
 solved so it will no longer be possible to save a new site with an incorrect email
 format entered for the site manager.
- Affected area(s): Viedoc Admin
 Bug description: In study settings, in the Documentation tab, the columns in the
 table for configuration of the Documentation and Training section were sometimes
 misaligned and poorly displayed. This has been solved so the table is displayed as
 intended.
- Affected area(s): Viedoc Admin
 Bug description: When users launched Viedoc Admin, a banner at the top
 stated the user has access to multiple organizations, regardless of how many
 organizations the user had access to. The information in this banner was
 considered redundant and has been removed for all users.
- Affected area(s): Viedoc Admin
 Bug description: In study settings, on the Logs tab, some labels were not
 translated from English. This is now solved and the labels are displayed in the
 language selected by the user.
- Affected area(s): Viedoc Admin
 Bug description: When adding a new study, the format of the Study Manager email
 address was not validated to confirm that it was a valid email address. This is now
 solved, and it will no longer be possible to add a new study with an incorrect email
 address format entered for the Study Manager.
- Affected area(s): Viedoc Admin
 Bug description: In the study design settings, "effective designs per site" always
 stated "multiple designs in use", even if only one design version was used. This field
 was considered misleading and redundant and has been removed.

- Affected area(s): Viedoc Admin/Clinic
 - Bug description: In the user administration log, the phone numbers of the users were not always displayed as expected, and the log had to be re-generated. This is now solved, so that, as long as a user has provided a phone number, it will be displayed in the user administration log.
- Affected area(s): Viedoc Clinic
 Bug description: When applying a revision to a site, if the revised version was not the
 latest effective design at the site, visit windows for initiated scheduled events (including
 Viedoc Me events) were calculated according to the latest applied revision. This has
 been solved so that the design version used for the event is used when calculating visit
 windows for scheduled events (including Viedoc Me events) in the study workflow.
- Affected area(s): Viedoc Clinic
 Bug description: When a repeating form was used in Viedoc Clinic, the lock icon was
 only displayed on the event if the max number of repeats had been added and all forms
 were locked. If a repeating form with unlimited repeats was used, the lock icon was
 never displayed on the event. This has been solved so that for forms with unlimited
 repeats, the lock icon is displayed for the event when all required forms in the event
 have been locked.
- Affected area(s): Viedoc Clinic
 Bug description: When randomizing a subject in Viedoc Clinic, the audit trail stated that
 the action of randomizing the subject is performed by "system" instead of the user. This
 is now fixed so that the audit trail will now instead specify the user who performed this
 action
- Affected area(s): Viedoc Clinic
 Bug description: When a user role had the permissions add/update subject/event/form
 data and query answers enabled, but did not have the edit rights for the kit allocation
 form, they could still allocate kits, and undo or perform the allocation again by selecting
 the Modify button. This is now solved so that a role must have add/update subject/
 event/form data and query answers enabled and edit rights for the kit allocation form
 to allocate kits and modify allocations.
- Affected area(s): Viedoc Clinic
 Bug description: For studies using the new Viedoc Coder, exporting to either Excel or
 CSV including medical coding with WHODrug resulted in the same ATC code showing
 for all drugs with the same Medicinal Product ID. This occurred even when different
 ATC codes were assigned. This is now solved, and the coded ATC is shown in the export.
- Affected area(s): Viedoc Clinic
 Bug description: In Viedoc Clinic, if a value was saved in an item, and that item was
 later confirmed as missing by a user without first clearing the value, the audit trail entry
 incorrectly showed that the system had cleared the value by confirming the item as
 missing. This is now solved, and the audit trail shows that the user cleared the value by
 confirming the item as missing.

Affected area(s): Viedoc PMS

exported designs might still cause this issue.

- Bug description: When exporting data in PMS studies, the filters "signed data" and "not signed data" did not work as expected. When using the filter "signed data" no data was included, and when using the filter "not signed data" all data was included. This has been solved so that the export filters "signed data" and "not signed data" work as expected.
- Affected area(s): Viedoc Designer Bug description: In rare scenarios, if a form was modified in a design revision (e.g. 4.3), then the design was exported and imported into a new study, and the new study was updated to that same revision version number (e.g. 4.3), the form was flagged with a red pen icon. This icon implied that there were changes to the design in that version in the new study, although the form had not been modified. This has been solved by removing the v4 attribute "v4:RevisedVersion" when exporting the design, to ensure these

attributes are not transferred from one study to another. Note that importing already

- Affected area(s): Viedoc Designer Bug description: In rare scenarios, if an item was added in a revision (e.g. 4.3), then the design was exported and imported in to a new study, and that specific item was removed in the same revision number as it was previously added in (e.g. 4.3), this led to errors when applying subsequent revisions in Viedoc Admin. This has been solved solved by removing the v4 attribute "v4:RevisedVersion" when exporting the design, to ensure these attributes are not transferred from one study to another. Note that importing already exported designs might still cause this issue.
- Affected area(s): Viedoc Designer Bug description: The v4 layout attribute "DisplayThumbnail" was incorrectly added in the ODM for more item types than file upload type. For other item types than file upload, the attribute was always set to "DisplayThumbnail="none"" and therefore never caused any issues in Viedoc Clinic, but it created irrelevant information in the exported ODM design files. This has now been solved, and the layout attribute "DisplayThumbnail" is now only added for the item type file upload. The redundant "DisplayThumbnail" attributes are left as is in current designs.
- Affected area(s): Viedoc Designer
 Bug description: When an item or an item group was deleted, the related ConditionDefs
 were not deleted in the ODM. This did not impact Viedoc Clinic, but led to irrelevant
 information in the design ODM. This is now solved, so now, when deleting items and
 item groups in a design, associated ConditionDefs will be removed.
- Affected area(s): Viedoc Designer
 Bug description: The v4 attributes "v4:AddedVersion" and "v4:RevisedVersion" were not
 specific to a study, making these attributes misleading when designs were exported
 from one study and imported to another (for example, from a study on the training
 instance to a study on a production instance), for a user who would review the exported
 design. For this reason, these attributes will, after the release, be removed when
 exporting a design.

Affected area(s): Viedoc Designer

Bug description: When the ODM design file was created through the study workflow, and when the value was expected to be v4:HideShow=show, the v4 attribute HideShow was not added to the ConditionDefs. This attribute was therefore not consistently defined for all of the ConditionDefs in the exported ODM design. This did not have any impact, as the absence of this attribute was treated as show by default. This is now solved, by always adding the v4 attribute HideShow to ConditionDefs when saving the study workflow.

Affected area(s): Viedoc Coder

Bug description: The new Viedoc Coder sometimes became out of sync with Viedoc Clinic and this bug was solved in 4.83, reported in the release notes for 4.83. The items that were out of sync before 4.83 require a resync which will be done after the release of Viedoc 4.84. After the resync, the items will appear correctly in Viedoc Coder.

- Affected area(s): Viedoc eTMF
 Bug description: Adding form fields to a PDF document was not working when a new document version was created by uploading a new file. This is now solved.
- Affected area(s): eTMF Archive
 Bug description: In some rare scenarios, generating the eTMF archive (eTMF EMS repository) was failing and resulting in an error message being displayed. This is now solved.
- Affected area(s): Viedoc Reports
 Bug description: A user with access only to the "Reports" tab in Reports (so no access to "Dashboard", "Demographics", "Adverse Events", or "Data Browser"), was not able to load Reports directly. The message "Disconnected from the server. Reload" appeared in the bottom left of the screen. This is now solved.
- Affected area(s): Viedoc Reports
 Bug description: For a locked study, the data sync in Viedoc Reports was not being
 performed one last time to get the latest data changes made before the study was
 locked. This is now solved, so that once a study is locked, the latest data is synced in
 Viedoc Reports.
- Affected area(s): Viedoc Reports
 Bug description: When data was edited in Viedoc Clinic by performing ONLY one
 or more of the following actions: reset forms, delete events, delete subjects, the
 scheduled (daily) data sync was not performed in Viedoc Reports, and therefore the
 deleted data was still present in Viedoc Reports. This is now solved.
- Affected areas: Viedoc Clinic
 Bug description: When the system language was set to Polish or Portuguese, some
 system texts were still displayed in English. This has been solved so the system
 languages are displayed as expected.

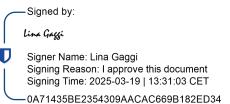
